## Terms and Conditions for Community Champion nominations.

Nominate a person to be a Community Champion. (the "Nomination(s)")\*. Terms of Participation in the Nomination (the "Terms")

## Definitions

For the purposes of the Terms, the following definitions shall have the meaning ascribed to them;

"Community Champion" means; means a person who goes above and beyond to make the lives of others better in their community which results in a positive impact in society;

"Nominator" means the individual making a Nomination;

  - 1.1.To be eligible you must:
